## Farrow Inc Fundraiser Agreement

This Agreement is made and effective as of \_\_\_\_\_ (“Effective Date”) by and between Farrow Inc., a Nevada Corporation (“Corporation”), whose address is 644 Columbus Parkway, Floor #1, Buffalo, NY 14213 and \_\_\_\_\_ (“Organization”), whose address is:

### **Corporation and Organization hereby agree to the following terms and conditions:**

- (a) Corporation and Organization will agree upon a date for the Farrow Memory Fundraiser Seminar (“Event”).
- (b) The Event is a partnership between the Corporation and Organization. Corporation and the Farrow Memory Speakers take the risk that Event may not have enough people to be financially viable. Corporation reserves the right to cancel Event if ticket sales are not high enough to justify the expense of travel and time of Corporation speakers and may cancel at any time, but no later than 2 Business days prior to the Event. Corporation and Organization members agree to do everything necessary to prevent a cancellation from happening. Organization agrees to help make the Event and this business model work effectively by promoting the Event vigorously, thereby helping more kids and reaching more people with this great information and helping Organization to raise more money.
- (c) Corporation will provide to Organization all fundraiser materials necessary for use in promoting and selling tickets for the Event. Fundraiser Package will be sent to Organization in advance of the scheduled Event date, giving ample time to promote the event.
- (d) All credit card payments will be charged by Corporation. All cheque payments will be made out to Farrow Inc, to be deposited by Corporation. Cash payments will be collected by Organization. Upon receipt of all payments, Corporation will reconcile all payment information; where necessary, any outstanding cash amounts will be sent to Corporation or from Corporation, depending on the number of cash tickets ordered.

(e) Profits from Event fundraiser will be shared between Corporation and Organization on a sliding scale, to promote and encourage ticket sales. Sliding scale is as follows:

\$0 - \$700.00 – All proceeds retained by Corporation for time and speaking fee

\$700.00 - \$1500.00 – 75% to Corporation and 25% to Organization  
(eg. \$1000.00 sales = 25 adult tickets at \$40 OR 50 youth tickets at \$20 OR mixture of adults and youth)

\$1500.00 - \$3000.00 – 65% to Corporation and 35% to Organization  
(eg. \$2000.00 sales = 50 adult tickets at \$40 OR 100 youth tickets at \$20 OR mixture of adults and youth)

\$3000.00 and above – 60% to Corporation and 40% to Organization

(f) Where applicable, Pizza Party prize for top selling group will be paid for out of Organization's fundraiser profits.
